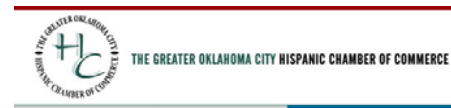

Programs of Service:

Child Care Resource and Referral (CCR&R)—through consultation with our Child Care Resource and Referral Specialists, families and the community are linked with accurate, useful information about child care options, quality indicators, and related resources that will assist with consumer education. Rainbow Fleet is a member of the Oklahoma Child Care Resource and Referral Association, Inc. and the National Association of Child Care Resource and Referral Agencies, and serves the children, families and communities in Cleveland and Oklahoma counties. Our Resource and Referral has earned national certification as a Quality Assured Program.

Child Care Resource Center – we offer parents, families and child care providers helpful hints, consultation and technical assistance on appropriate activities, curriculum, educational materials and resources for children in a unique lending library setting.

Child Care Health Consultant – our Registered Nurse provides consultation for child care providers on an array of issues addressing the health and safety of the children in their care.

Hispanic Services – our Hispanic Referral Specialist is bilingual and provides referral assistance and consumer education to our Hispanic population.

Infant Toddler Consultant – our specialist successfully earned certification from the WestEd Program for Infant Toddler Care and provides technical assistance and training on appropriate infant toddler environments.

Child Care Training Workshops – we coordinate training and consultation to assist child care providers in meeting training requirements for licensing, the Reaching for the Stars quality initiative, and other levels of early childhood professional development training such as First Aid/CPR and Accident and Disease Prevention.

Child Care Food Program – as a sponsoring organization with the Child and Adult Care Food Program, we reimburse family child care home providers for the children’s nutritious meals and snacks that meet USDA guidelines and servings.

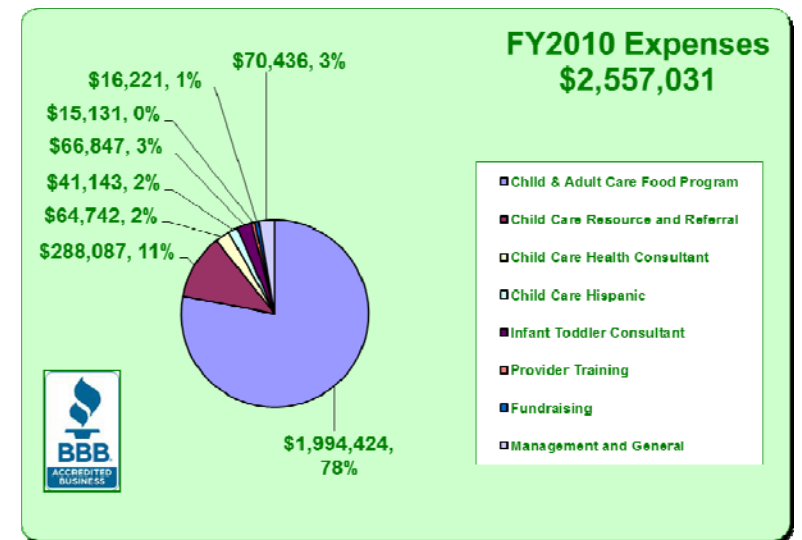
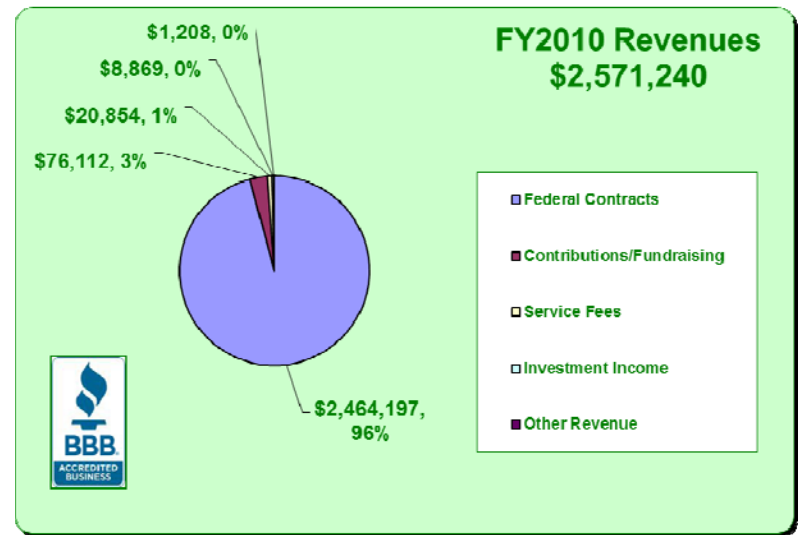
